Avocet should always be used with an approved adjuvant.

* Topik is supported in mix with Avocet up to the end of February.
[®] Residual herbicides can be used in mixture or short sequence with Avocet, while conditions are favourable for both products to work and weeds are small and actively growing. However, once soil moisture declines to reduce residual activity then a **4 week** interval between the residual herbicide and an application of Avocet is recommended to maximise grass weed control and the tank-mix is no longer supported.
* Do not exceed maximum total dose of florasulam within growing season.
** Do not use this mix if the crop is under stress as there is the increased risk of an additive PGR effect and possible crop damage
† Corteva Agriscience only support Avocet in a 2-way tank mix with half rate chlormequat due to crop safety issues. An intervals of at least **7 days** must be regarded before applying a higher rate of chlormequat or any other PGR.

Do not mix Avocet With OPs, MCPA and Dicamba.
For products containing MCPA or Dicamba respect a 14 day interval between them and Avocet.
Do not harrow or roll within 7 days before or after an application of Avocet.
